Discernment and decisions - Canvass

The board discussed the history, complexity, and benefits of the Canvass. A long term goal is to develop a standing Canvass committee that can be grown over time with institutional knowledge. As we approach the 2021 Canvass (Sunday, March 7), there is an immediate need, requiring board leadership.

Next steps:

- Gather the two teams
- Articulate the roles that need to be staffed
- Recruit for gaps
- Brainstorm alternatives to traditional canvass

BH, BW, and GG will staff the Canvass, along with EPS and volunteers mentioned. LJ, KW, and MC will focus on exploring stewardship questions and the balance of funding, volunteerism, and sharing of talents. A key point for this balance is that the Bylaws place fundraising under the auspices of the Board, while Stewardship is an activity of Lay Ministry.

Treasurer's Update

The November Treasurer's update was shared with the board and is attached to these minutes. During the meeting, the board reviewed the long term maintenance and upgrade plan. Recommendations around non-brick and mortar needs such as the sound system are also being planned for by the Finance committee.

Urgent request for roof repair

• The board commends Karl, Dan, Bill, and Narcy for rapidly gathering information related to due to water damage.

- Water was leaking through the main Sanctuary roof and (beginning to damage interior) and also through flat part of Bldg 5 roof near elevator (already damaged drywall).
- Due to the urgency of the need, the board followed up via virtual votes.

Secretary's Updates

Meeting minutes for November were distributed December 8th and were reviewed and approved. Motion by BH, second by DH, motion carried unanimously. Service schedule was distributed by email.

Review of virtual board votes held in between meetings:

- UUCR Policy for Building and Ground Usage During the COVID Pandemic –Facilities
 use policy. Following the November board meeting, the board developed and reviewed a
 policy on building access and grounds use. BW motioned for approval, seconded by DH,
 with the motion passing unanimously. The policy has been <u>posted</u> in several locations
 on the UUCR website, including the <u>policies page</u>.
- Motion by DH to approve the funding request presented to the Board via email on November 27th, which authorizes the use of \$7,761 (combined) from the Site Beautification Operating Fund and the Remembrance Fund, split evenly. These funds will be used by the Landscaping Committee for a contract with Fine Earth to refurbish the Memorial Garden, as further described in the funding request package. This package has been reviewed by the Finance Committee and Treasurer DH. Seconded by LJ, and the motion passed unanimously.
- The board developed and reviewed a ELECTRONIC MEMBER DIRECTORY POLICY, describing the use of Realm to share congregational information with staff and among congregation members. Data accessible to all UUCR Realm users will include Name, Home Address, Phone Number, Email address, barring opt out. Motion by BW to approve, second by LJ, and the motion passed unanimously.

Minister's Report for December 2020 Treasurer's Report, December 12, 2020 Greetings and Salutations beloved Board of UUCR:

Our worship theme for the month of December is "Stillness", which invites us to a time of reflection and quieting our spirits as we wait for the rebirth of the sun with the Solstice, and for hope reborn with the lights of Chanukah and the birth of a prophet.

And yet, we are as engaged as ever as a spiritual community in our theme of the year of Love, Serve, Grow. Since Water Communion and Ingathering, almost every single committee and group have pivoted successful to online platforms and other forms of engagement. So I wanted to share with you just some of the tremendous programs that have taken off at UUCR.

- First Friday Concerts: Sarah Jebian has welcomed tremendous musicians and this past Friday with Lea Morris was no exception. Sarah shared that due to robust outreach, the attendance and participation was doubled from last month.
- Monday Night Meditations: Justin Furnia has created a beautiful space to share his ample gifts. Members and friends near and far have tuned in.
- Thanksgiving Basket and Gift Card Massive Success! With the option of virtual coordination, the outpouring for this outreach led to 25 baskets from UUCR and over \$2k in grocery store gift cards. The largest achievement to date!
- Memorial Committee: With Kent Hancock and Bruce Basket's leadership, the Memorial Committee has taken shape, providing more ability for us to honor our Beloveds who have died and care for their families. With the addition of Sherry and the Planned Giving Committee, we have identified smoother communication in order to fulfil memorial gifts.
- Pastoral Care Committee: With over 20 lay pastoral care leaders, pastoral care continues to thrive. Each week the ministry team and PCT connect with those in need, as well as send cards and include "Thinking of You" notes.
- Family Faith Formation: The Grow Garden project is taking off! Soon bulbs will be planted and Carla Miller shared that new/new-ish folks are participating in the project, which is a wonderful way for them to connect more deeply with UUCR. Also, Carla recruited a group of people to deliver the monthly RE bags to our families, which has been a huge success! Our drivers love to wave "Hi" to our families, and our families stay connected to our faith formation interactive activities. A big win all the way around.
- Small Group Ministry: Thanks to Marsha Luce and Bonnie Bloomquist, we have seven robust SGM circles going. They meet twice per month, once to check in and once for the Soul Matters materials. Many have shared that their SGM is a special life line in this challenging time. AND, we have now added a SGM at Asbury! Retired UCC minister and Asbury resident, Donna Schramm shall be leading the existing group that was seeking more support and structure.
- One on One Project with the Rev: Thanks to Margie Henry and Marianne Miller, I have now been able to meet with close to three dozen UUCR members and friends. We have spent from half an hour to a full hour together, and been able to talk about everything and anything they wish. It has been an honor and delight to get to know so many people better, and connect them with areas of UUCR they are interested in.

In this time of Stillness, may we pause to appreciate the generous souls that contribute to the health and well-being of UUCR.
